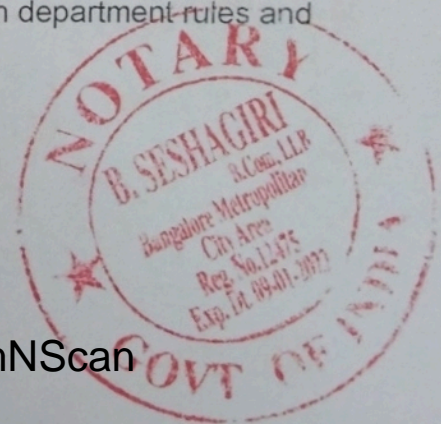

5. The governing body shall be governed by the same place and name as the school is authorized to deliver, and for any reason without the prior approval of the government / department.

6. The educational institute should follow all the rules as applicable.
7. The educational institute should follow all the curriculum, books and examinations as per the educational department
8. Renewal of accreditation by relevant authorities within three months of registering the school.
9. The proportion of children and teachers in each approved class shall be governed by the rules

11. Medical examination of students should be regulated every year.
12. According to the rules of the Karnataka Education Bill, the school has to be equipped with furniture, furniture, library books, playground and school building. Registration will be canceled.
13. School working days and timings shall be observed as per departmental rules.
14. The school will follow the mother tongue of the Kannada media as per the latest Language policy from 1st to 5th standard.
15. The school should be informed of the school openings and the enrollment of the students within two months of the school enrollment or academic year. If the school is not open and no conditions are met, the order is automatically canceled.
16. The school cannot in any case open more sections without the government's prior permission.
17. All schools registered under subsection 36, 37 of the Karnataka Education Bill are covered by Recognition and provisional Registration,
18. Karnataka Private Educational Institutions (Recruitment, Service Clause and Provisions of Employees of Privately Funded Primary and Secondary Education) It is the responsibility of the Governing Council to start a service for teachers, pay through the bank and provide service security.
19. The school's permanent funds shall be deposited in the Nationalised Bank in accordance with the Joint Account of the Field Instructors, Public Education Department and Administrative Secretary.
20. Separate toilet and drinking water system for girls and boys in school should be provided.
21. Arrange the school premises and premises to be safe for students, teachers and staff from fire, accident, electrical accident and other hazards. The Supreme Court's Case No: 483/2004, The Directive dated 13-4-2009 must be complied with.
22. Every year school enrollment must begin after April 10th. The government's reservation rule should be mandatory and the locals should be given priority.
23. The Rights of the Child for Free and Compulsory Education shall be registered in accordance with the provisions of the Act 2009 and in accordance with the regulations.

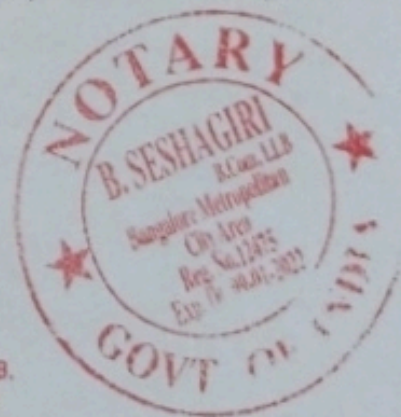

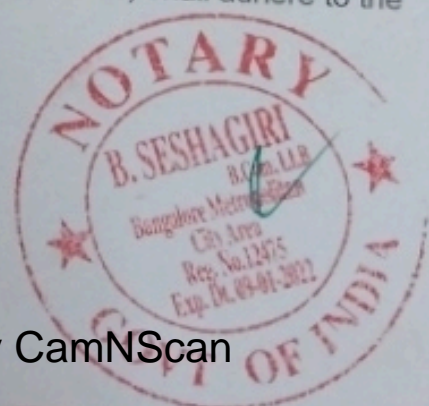

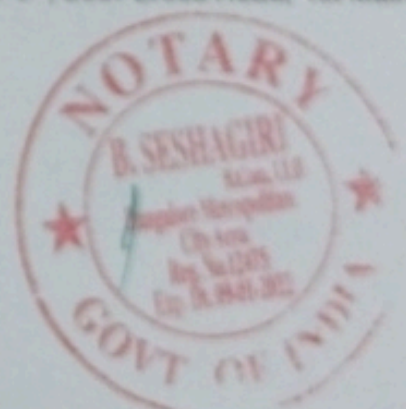
